

**WUSN/Funjet Vacations Flyaway Friday (1/14) Contest  
OFFICIAL RULES**

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.  
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

1. HOW TO ENTER

- a. These rules govern the WUSN/Funjet Vacations Flyaway Friday Contest (the "Promotion") being conducted beginning on Tuesday, January 12, 2011 at 7 PM, by WUSN (the "Station") and ending at approximately 4:00 PM CT on Friday, January 14, 2011.
  
- b. To participate in the Promotion, you must be the 19<sup>th</sup> caller after Zac Brown's song "Toes" begins to play on Friday, January 14, 2010. The exact time the song will play will be posted in the rotating box on US99.5 home page at [www.us99.com](http://www.us99.com) between Tuesday, January 12, 2011, beginning at 7:00 PM CT and Friday, January 14, 2011 and 4PM CT, and be included the US99.5 e-newsletter being sent out on Wednesday, January 12, 2011. Upon hearing the song begin to play, the 19<sup>th</sup> caller will win upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line completely and answers the question correctly will be the winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be one winner selected on-air during the Promotion dates. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the WUSN online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are 21 years of age or older and reside in the Greater Chicago Land Metropolitan Area in Illinois, Indiana and Wisconsin (**Cook, Will, DuPage, Kane, Kenosha, Lake County, IN, Lake County, IL, Kendall, McHenry and Porter counties**). Employees of Station, its licensee, the licensee's parent, subsidiary and affiliated entities, Station's advertising and promotional agencies, its participating sponsors, other radio stations in the

Chicago metropolitan area, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. The winner must complete a WUSN contest release form and also provide valid government-issued photo identification, provide their complete address, date of birth, and phone number to claim a prize.
- c. Entrants are required to provide truthful information and the Station will disqualify any contestant that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements.
- d. Winner and guest will need a valid passport for travel to international destinations.

### 3. PRIZE

One (1) prize will be awarded during this Promotion. The description is detailed below:

**Destination:** Riviera Maya

**Hotel:** RIU Palace Mexico (all-inclusive)

**Number of Nights:** 4

**Transfers:** Round trip transportation between Cancun airport and RIU Palace Mexico.

**Valid Travel Dates:** April 26 – May 25; June 4 – 23; August 16 – November 19, 2011; November 29 – December 15, 2011; January 5-21; April 15 – May 25; June 4 – 23, 2012

**Departing From:** Chicago

**Departure Days:** Based on charter schedule

**Total Retail Trip Value (for winner tax purposes only):** \$1235.00 per person

**Other Details:** Winners must be at least 21 years of age. Blackout dates will apply. All travel is based on availability. Winners will need to valid Passport for travel to international destinations. If Passport is not in hand by time of travel, there will be no refunds nor extensions. Winners are responsible for any charges incurred for winner

name changes or trip cancellations. Trips are nontransferable and not redeemable for cash. WUSN is responsible for issuing 1099 tax forms to winners based on trip value. Should either the hotel or destination be dropped from the FJV product line prior to booking, FJV shall have the right to substitute a comparable hotel or destination.

**IMPORTANT NOTICE REGARDING NEW PASSPORT REQUIREMENTS FOR INTERNATIONAL TRAVEL– As of January 23, 2007 all international travelers must present a government issued passport for U.S. Customs re-entry after air, land or sea travel. For more information please visit the State Department’s consular website [www.travel.state.gov](http://www.travel.state.gov) or the U.S. Department of Homeland Security’s website [www.dhs.gov](http://www.dhs.gov). It is the traveler’s responsibility to provide proper documentation. Married or divorced women traveling under names other than what is printed on their travel documents must supply a marriage license and/or divorce decree.**

Approximate Retail Value: \$ 2,470

- a. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. The Station accepts no responsibility for repairing any real or supposed damage to any prize.
- b. All prizes or prize certificates will be mailed to the winner; prizes may be picked up at the office of the Station at the 180 North Stetson Suites 1000, Chicago, IL 60601. The winner will forfeit any prize or prize certificate not claimed within fourteen (14) days of winning. The Station is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that the Station may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. One winner will be awarded the prize.
- c. As per 1.b of these official contest rules, the 19th caller to reach the station’s contest line at (312) 591-8799 will immediately win the Prize based on confirmation of eligibility.
- d. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within fourteen (14) days of winning or prize will be forfeited and an alternate winner will not be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or

liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

## 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station, in its sole discretion, may require Promotion winner (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless the Station, its licensee, the licensee's parent, subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right to select the winners by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winners.
- e. WUSN, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify

that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. WUSN reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel or modify the Promotion and shall not be required to award a substitute prize.
- g. WUSN is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
