

**US99.5 “MLPP Professional Championship Bullriders Tour featuring Jake Owen”
Official Sweepstakes Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

1) HOW TO ENTER

- a) The WUSN (the “Station”) “MLPP Professional Championship Bullriders Tour featuring Jake Owen” sweepstakes (the “Sweepstakes”) is a promotion that will take place on January 28, 2011 at Galway Inn located at 12045 W. Roosevelt Rd, Elmhurst, IL 60126 from 9:00 pm to 11:00 pm CT.
- b) To participate in the Sweepstakes, listeners must stop by Galway Inn from 9:00 pm to 11:00 pm CT, on January 28, 2011 to obtain and fill out an official entry form, available on location while supplies last. Contestants must provide all information requested, including their first and last name, complete address, including zip code, daytime telephone number and date of birth in order to be eligible for a chance to win. Entry forms must be dropped in the designated drop box or handed to the appropriate representative once completed. Entries must be received before each drawing. **Drawings will take place every twelve (12) minutes between 9:00pm and 11:00pm during the station appearances.** All entries must be received between 9:00 pm and 10:55 pm CT to be eligible.
- c) The Station will select ten (10) potential winners in a random drawing from all entries received. Each selected winner will receive one (1) pair to the Professional Championship Bullriders Tour on either February 4th featuring a post-concert with Jake Owen or February 5th with no post-concert, upon confirmation of Sweepstakes eligibility. Potential winners will have 6 minutes to claim the tickets before an alternate winner be selected.
- d) **Must be 21 years or older and must be present to win.**
- e) One (1) entry per person, please. No photocopies or mechanically reproduced entries will be accepted.
- f) The Station and the participating sponsors of this Sweepstakes (hereinafter collectively referred to as the “Sponsors”) assume no responsibility whatsoever for any lost, misdirected, illegible, stolen, incomplete, mutilated, or late entries. All entries become the exclusive property of the Station and will not be returned.

2) ELIGIBILITY RESTRICTIONS

- a) The Sweepstakes is open to all Station listeners who reside in the Greater Chicago Land Metropolitan Area in Illinois, Indiana and Wisconsin (Cook, Will, DuPage, Kane, Kenosha, Lake County, IN, Lake County, IL, Kendall, McHenry and Porter counties), and who are 21 years of age or older at the time of entry. Employees of the listed MLPP locations, the Station, its licensee, corporate parents, subsidiaries and affiliates, its advertising agencies, participating sponsors/promotional partners, and other radio stations in the Chicagoland Area

and immediate families of such persons and those living in the households of same are not eligible to participate or win.

- b) Entry into the Sweepstakes constitutes your agreement to be bound by these Official Sweepstakes Rules.
- c) Winners will be required to present valid government issued photo identification and to sign all required releases in order to claim their prize.

3) **PRIZES**

- a) Ten (10) prizes will be awarded at each station appearance. Each prize consists of one (1) pair of tickets to see the Professional Championship Bullrider Tour on either February 4th featuring a post-concert with Jake Owen or February 5th with no post-concert. Tickets will be awarded on-location during the Sweepstakes Period. Winners are responsible for all expenses, including travel, to the event. **ARV: \$44.00 per prize**
- b) Prizes must be claimed on location at the conclusion of each Station. Any prize not claimed within 6 minutes of their name being called will be forfeited and an alternate winner will be selected. Tickets cannot be exchanged or refunded.
- c) Sweepstakes prizes are not transferable. Prizes may not be substituted or redeemed for cash except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4) **SELECTION OF WINNERS**

- a) Decisions of Station management with respect to the Sweepstakes are final.
- b) Ten (10) winners will be selected at each station appearance in the manner set forth in Section 1 of these rules.
- c) Winners must be present to win. Winners will be notified of their prize on location. If a winner is not present when their name is called, an alternate potential winner will be selected in a random drawing of all entries and announced until an eligible winner is found. If a person is not present when their name is called, their name will not be returned to the entry box.
- d) Odds of winning depend upon the number of eligible entries received.

5) **CONDITIONS**

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station, in its sole discretion, may require Promotion winner (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless the Station, its licensee, the licensee's parent, subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right to select the winners by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winners.
- e. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. The Station reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel or modify the Promotion and shall not be required to award a substitute prize.

g. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
